Fire Chief's Report: Chief Scott Lynch

- 1) Volunteer Status: One volunteer was interview need background and physical paperwork
- 2) **Station Status:** Asked if Bethany can get the computer to work and get the laptop Scott has to connect to the projector. Also get a new phone and see what it would take to get the fax working correctly
- 3) **Truck/Equip Status:** The Military truck should be done ready in the next three weeks, this will be B51. US Forest truck is getting worked on by mechanic, this will be A51. E52 needs to be finished getting outfitted, mostly handtools.
- 4) Training Status: EVIP Drivers Training, Makeup Classes for all

5) Other: Scott is going to try and get the light pole started, depending on availability of a mini excavator. Bethany is going to check in with Valley Ag about replacing the gauges again.

Committee Reports

- Isla Durheim: SCFCA Meeting had the Reginal Rescue Task Force demonstration and explained how they are doing Sheriffs Office and Firefighter training to calls
- Dave Alvarado: wondering if the community could use one of the billboard signs to advertise selling products ex; eggs, beef, ect. Dave is going to make a draft agreement to see if it would work. Was wondering about the plan for the weeds in the corner. Bonita is planning on laying weed barrier and rocks, as well as spray when the weather is warmer. Advanced System asked if we wanted a maintance agreement. The agreement is for \$125 for one minisplit and \$75 for each after, totaling to \$275. This agreement can be quarterly, bi-annually, annually, or monthly. Bonita made a motion to start a bi-annually agreement (twice a year) to be updated if needed. Dave Seconded and the motion passed unanimously. Dave also asked if the volunteers would like a gift card for the most calls per quarter, Scott said not at this time.
- **Bonita Cobb:** The Wildfire Awareness event on May 3rd will be from 12-2pm. We have the opportunity for another structure engine. The department has no current room for another engine however the Huttarian's have agreed to keep it inside a heated building all year and there are enough volunteers to have a full crew when the truck is needed. The truck will be donated by Spokane City Fire Department. Scott is going to look at truck before final decision and Bethany will check in with Enduris about premiums for adding a new truck.
