Fire Chief's Report: Chief Scott Lynch

- 1) **Volunteer Status:** Get Thank you for service cards for volunteers who have retired or leave the district. Bethany is going to get the cards, Scott is going to get a \$50 gift card for a volunteer who has retired.
- 2) **Station Status:** Volunteers haven't tried to use projector lately Bethany will check on getting laptop connected to projector or get an IT person to come set it up. The heaters have been turned off at ST 52, Bethany is going to get in contact with Advanced Mechanical to complete the service contract.
- 3) **Truck/Equip Status:** The Military Truck is going to need to get a radio, swapping with a different truck. The US Forest Truck is back from Terry's Truck, will also need radio swap. The Wildland Equipment has been purchased, most also received.

- 4) **Training Status:** Brush truck familiarization, Drafting and pumping operations(the white tanks on home owners property are no longer in use. We have new water sources, St 53 and a couple at different home owners that are in use.) Trauma and Immobilization
